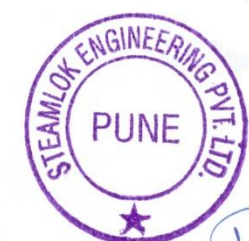

Sub.: Approval for Manufacturing of "Mountings and Fittings" as per Indian Boiler Regulation, 1950.

Gentleman,

With reference to your letter reference No. **IBR/SLPL**, dated **04-01-2024**, and subsequent visit of and Inspecting Officer of this Directorate to your workshop on **28-03-2024**, for purpose of verification your competency as a "**Mountings & Fittings Manufacturer**" I have to inform you that the same is found satisfactory. You are now provisionally permitted to manufacture the same coming under the purview of Indian Boiler Regulations 1950 and supervision of this Directorate for a period up to **31.12.2024** subject to following condition :

1. Drawings for all the Mountings/fittings to be manufactured should be submitted to this office, along with original receipted challan, after paying necessary fee as prescribed, under Maharashtra Boiler Rule, 1962, and approval should be obtained before commencement of manufacturing.
2. Maker's certificates of raw material viz. pipe bars, billets & forgings etc. to be used in the manufacture of pipe fittings should be submitted to this office, for scrutiny and acceptance, before use.
3. Pipe fittings should be offered for inspection at various stages of manufacture, as laid down in appendix "J" of the Indian Boiler Regulation 1950.
4. Consumption record of raw material used in manufacturing of fittings should be mentioned on back side of certificates of the raw materials and produced to the Inspecting Officer for verification & endorsement.
5. Welding / repair to the fittings excluding mountings of welded consumption should not be done unless prior permission of the Director of Steam Boilers, (M.S.) is obtained.
6. As per rule 152(3) of Maharashtra Boiler Rules 1962, any change in Production/Quality Control related staff should be immediately informed to this office.

9. All instructions and directives of this Directorate should be strictly followed.

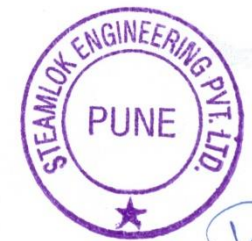
